Terms and conditions:

- 1. The sealed tenders in a letter pad in prescribed proforma should be super scribed as "Tender for Supply of Chemicals, Reagents, Diagnostic kits, Discs and Glass wares etc." are to be submitted in the office of the undersigned on or before 3.00 P.M of 3.02.2021, through Regd. Post / Speed Post / Courier and the tender will be opened on 4.02.2021 at 11.00 A.M in the office of the undersigned and it may be extended. The tenders received beyond the scheduled date and time will not be considered under any circumstances.
- 2. The Tenderer should furnish the Earnest Money Deposit (EMD) of Rs.20,000/-(Refundable)(Rupees Twenty thousand) only in shape of Bank draft in favour of the Dean & Principal, SLNMCH, Koraput. payable at SBI, Koraput, Odisha. The E.M.D will be forfeited, in case the successful tenderer fails to execute the order within the stipulated period.
- 3. The tenderer should submit the EMD and tender document fees in technical bid.
- 4. The tenders received after due date and time will not be considered under any circumstances and The price bid will be opened whose tender will be qualified in the technical bid.
- 5. The tenderers or their authorized representatives may attend on the date / time of opening of tenders. If any tenderer or their authorized representatives fails to turn up at the time of opening of the tenders, the process will continue as usual.
- 6. The tenderer should supply the chemicals, reagents, kits, discs and glass wares etc. of the brands Dako//Loba//Tulip/ J.Mitra//Bayer//BlueStar/ JSGW//Jain Co. / Stanbio// Crest/ Tarsons/ Borosil/ Riviera/Sigma-Aldrich/ IDT//Bioscience / Transasia/ Roche/Merck Life Science//SRL//HIMEDIA//NICE//Invitrogen//Whatman (TM) and other brands to this organisation.
- 7. The tenderer should submit the attested photo copies of authorization letter of manufacturers / Principal firms, otherwise tender for the item will not be considered.
- 8. The chemical etc. to be supplied must have expiry of one year on the date of supply and they have to supply demo kit for quality assessment to different departments if required.

- 9. If any information or documents furnished by the tenderer found to be misleading / in correct at any stage their tenders will not be accepted.
- 10. The committee is not bound to accept the lowest rate and highest discount offer considering the technical aspects.
- 11. The rates so quoted should be on door delivery at concerned department of SLN. Medical College, Koraput, Odisha.
- The tenderer should submit up to date printed price list of products after selection of the respective brands.
- 13. The tenderer should furnish up-to date Photostat copies of the Valid GST certificate as per Govt. rule, valid PAN Card, valid ISI/ISO/GMP certificate, Valid Drug Licenses, Valid manufacturing license/Authorization certificate, for the items.
- 14. The tender will be valid for one year from the date of approval / may be extended with the same terms & condition subject to satisfactory performance / till finalization of next tender.
- 15. All legal disputes, if any relating to purchase etc. are subject to jurisdiction in the courts of law situated at Koraput, Orissa.
- 16. The Dean & principal, S.LN Medical College and Hospital, Koraput reserves right to accept / reject / cancel any or all the tenders in full or part without assigning any reason thereof.
- 17. The tenderer should adhere the terms & conditions and submit the bids in given prescribed proforma failing which the tender paper will be cancelled.
- 18. Tenderer who has been blacklisted either by the tender inviting authority or by any state Govt. or Central Govt. organization should not participate in the tender during the period of blacklisting.
- 19. The payment will be released only after clearance certificate received from concerned HODs.
- 20. The tender documents should be clearly written / typed without any corrections, interpolation and over-writings etc and each page of the tender should bear the dated signature of the tenderer.
- 21. The quoted rates should be in Indian Currency, both in words and figures against eachitems.
- 22. The price quoted should be final and shall not be subject to any escalation during the validity of the tender.
- 23. The tenderer should submit/ furnish a certificate in the tender to the effect that price quoted by him / them is not more than the Open Market Price or also not more than the rates under of D.G.S. & D, New Delhi where such rates exist.

- 24. If the manufacturing firms are directly submitting the tender, they should not authorize any agent to quote for the same products simultaneously.
- 25. The successful tenderer shall have to furnish the security deposit @10% of the accepted value of the tender as guarantee with the Dean & Principal, S.L.N Medical College and Hospital, Koraput after receipt of purchase order with in a fortnight, if required. Such security deposit shall be in shape of Term deposit / D.D / Bank Guarantee duly pledged in favour of the Dean & Principal, S.L.N Medical College and Hospital, Berhampur. The security deposit furnished by the successful tenderer shall be refunded only after successful completion of the guarantee period.
- 26. To ensure sustained supply without any interruption, the Dean & Principal reserves the right to split orders for supplying the requirements among more than one tenderer provided that the rates and other conditions of supply are equal and with sufficient grounds. In case of non supply of any items by any approved lowest quoted firm, the Dean & Principal can offer any of L-2 firms to supply at L-1 rate (lowest approved rate) and procure the same items in L-1 rate sequentially.
- 27. No advance payment towards cost of items will be made to the supplier. Payment shall be made on receipt of the stock entry certificate on the body of the bill/invoice from the concerned Deptts as well as store.
