**ADVERTISEMENT FOR FILLING UP OF POST OF JUNIOR RESIDENTS ON CONTRACTUAL BASIS  
IN SLNMCH, KORAPUT**

Eligible candidates are invited for Walk-in-Interview for selection to the post of Junior Resident in SLNMCH, Koraput on contractual basis. The applicant must have acquired the required qualification for the post applied for, on or before the date of counselling. The engagement shall be purely temporary for a period of one year which may be extended on year-to-year basis for a maximum period of three years subject to requirement and satisfactory performance. The posts are non-practicing. The candidates will be paid consolidated amount of **Rs.60,000/-** (Rupees Sixty Thousand) only per month. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. Eligibility of application will be guided as per the provisions mentioned here under.

**1. Available vacancy : 01**

(The above vacancy is strictly provisional. It may change on the date of walk-in-interview as per requirement)

**2. Age : Must be less than 70 years.**

**4. Eligibility and Qualification for Junior Residents**

**a. Qualification:**

- i. A candidate must possess a MBBS degree (for Medical stream) recognized by MCI/NMC/as the case may be.
- ii. The candidate must have completed the compulsory one-year rotating internship
- iii. The above qualifications must have been obtained on or before the date of counselling.

**b. Other Eligibility Conditions:**

- i. The candidate must be a citizen of India.
- ii. The candidates must have registered their Medical Qualification at Central/ State Medical Council. (Permanent Registration)
- iii. Candidates having post-graduation in any discipline or are continuing or have completed three years tenure as Senior Resident/ Tutor in any MCI/ NMC permitted/ approved/ recognized institute are not eligible to apply.
- iv. Candidate who are serving under OMHS cadre on regular basis are not eligible to apply.

## 5. Procedure of Application:

The Candidate shall download the Application Form annexed in this Advertisement (Page 4 & 5) and come for the interview with duly filled in Application form and all requisite original documents. They have to come with a demand draft of **Rs. 500/-** in favour of "SLNMCH RECRUITMENT" Account No. **43231659018** payable at State Bank of India, SLN Medical College Branch, Koraput (IFSC Code-**SBIN0064554**) towards application fees. The application fees is not refundable at any circumstances.

## 6. Procedure of Interview:

Interest candidates shall fill up the Google form as a pre-registration process to participate in the walk-in-interview latest till **11 am of 17.10.2024**. Without pre-registration the candidate will not be allowed to participate in walk in-interview.

- I. The Candidate shall appear personally before the Convenor as per schedule and submit the application form duly filled in alongwith the following documents in a chronological order.
  - a) One passport size recent color photograph signed by the candidate at front to be pasted on the application form.
  - b) Demand Draft of **Rs.500/-**.
  - c) Self attested photocopies of:
    - H.S.C./ Equivalent certificate in support of age
    - +2/Equivalent examination certificate
    - MBBS pass certificate
    - Mark sheet in support of all the aforesaid examination (i.e. from H.S.C onwards) passed including fail marks.
    - Chance certificate of MBBS
    - Internship Completion Certificate
    - Certificate of Medical Registration (up to date)
    - Valid Photo ID issued by the Govt. authorities i.e Passport/ PAN Card/ Voter ID card/ Aadhar Card
  - d) All Original Documents
- II. At the time of documents verification, physical presence of the candidate is mandatory and no authorization will be entertained. The candidates who fail to produce the **original documents & submit un-filled application form** during walk-in-interview **will be rejected.**

**N.B:** In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/ her application shall be rejected and disciplinary/ legal action as deemed proper will be initiated against him/her.

## 7. Selection of candidate:

- a) After successful verification of the documents, a Provisional Merit list shall be prepared on the basis of career marks and notified in the website of SLNMCH i.e. **www.slnmch.nic.in**.
- b) The grievances from the candidates, if any, will be allowed to be put forth to the official mail **slnmchkptrecruitment@gmail.com**.





- c) The grievances if any will be examined and a final merit list will be notified in the website. The final list will remain valid for a period of one year or till subsequent advertisement whichever is earlier.
- d) The appointment/ engagement order shall be uploaded in the website of SLNMCH, Koraput.
- e) In case the candidate appointed, fails to join in time, then the next candidate in the panel for the subject may be given a chance.

#### 8. Selection Process:

- a) Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:
  - HSC/ Matriculation-20% of total percentage of marks secured.
  - Intermediate Science-20% of total percentage of marks secured.
  - MBBS/ M.Sc examination-60% of total percentage of marks secured.One mark will be deducted from the total Career mark for each extra attempt taken to pass the examination.
- b) In case of Foreign Medical Graduates (FMG) the marks secured in the subject as per the NMC/ MCI conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such a marksheet, their marks will be taken as 50%.
- c) In case of tie, it will be resolved as follows:
  - i. The candidate securing more mark in MBBS/M.Sc shall be placed in higher rank.
  - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- d) The selection committee at their discretion may short list the merit list to reasonable number as per the vacancy.
- e) Any clarification/corrigendum/ addendum if required shall be notified by the convener in the website of SLNMCH, Koraput i.e. [www.slnmch.nic.in](http://www.slnmch.nic.in). All communication shall be made through the website of SLNMCH, Koraput (No Postal/ Personal Communication will be made)
