**DETAILED ADVERTISEMENT FOR ENGAGEMENT OF SUPER SPECIALIST DOCTOR IN
SLNMCH, KORAPUT**

Applications are invited from the aspiring eligible candidates for engagement of the Super Specialist Doctor for various disciplines in SLNMCH, Koraput on weekly or biweekly basis. The details of eligibility criteria/ qualifications / posts etc. are as under. The engagement will be for a period of **01(one) year** which can be extended from time to time subject to satisfactory performance of the candidates. The candidates working under any Govt. Health Institute are not eligible to apply. The eligible candidates for the posts mentioned below may apply in the prescribed Application Form to the **O/o the Medical Superintendent, SLNMCH, Koraput, PIN-764020 by dt. 07.03.2025 upto (05.00 P.M.) thorough Regd. Post / Speed Post/ E-mail i.e. (supdtslnmchkpt.od@gov.in)**. The application must be super scribed or named in case of e-mails as " Application Form for the post of (name of the post)".

1. Name and No. of Posts:

2. Age :

The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age up to which one can serve is 70 yrs.).

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

3. Schedule of Walk-in-Interview :

Date of Interview - **will be intimated through e-mail.**
Time - 10:30 AM
Venue - O/o the Medical Superintendent, SLNMCH, Koraput

4. Eligibility and Qualification :

- i) The candidate must be a citizen of India.

- ii) The candidate must possess DM/ MCh/ DNB degree in the concerned discipline from any MCI/NMC approved recognized/ permitted Medical Colleges.
- iii) The Medical Graduates must have registered himself/ herself under any Odisha /Central Medical Council /NMC/ MCI after obtaining the degree (Permanent Registration)
- iv) The above qualifications must have been obtained on or before the date of interview.

5. Procedure for Application:

Candidates shall download the Application Form annexed in this Advertisement (Annexure-I) from <https://slnmch.nic.in/> or <https://koraput.odisha.gov.in/> and come for the Interview with all duly filled in Application form with all requisite original documents.

6. Procedure of Interview:

- I. The candidate shall have to appear personally before the undersigned in the office of the Medical Superintendent, SLNMCH, Koraput alongwith the following documents on a scheduled date and time which will be intimated to the candidates by e-mail / published in the website: <https://slnmch.nic.in/>:
 - a) Duly filled in Application Form.
 - b) One passport size recent colour photograph signed by the candidate at front to be pasted on the application form.
 - c) H.S.C./ Equivalent certificate in support of age.
 - d) +2/Equivalent examination certificate.
 - e) MBBS, MD/MS, DM/MCh/DNB Pass Certificate.
 - f) Mark sheet in support of all the aforesaid examination (i.e. from H.S.C onwards) passed including fail marks if any.
 - g) Chance certificate of MBBS,MD/MS, DM/MCh/DNB
 - h) Valid Certificate of Medical Registration from Odisha /Central Medical Council (Both UG , PG & Super speciality)
 - i) Copy of Research Publication
 - j) No Objection Certificate from current employer
 - k) Valid Photo ID issued by the Govt. authorities i.e. Passport/ PAN Card/ Voter ID card/ Aadhar Card)
 - l) If a candidate claims to possess qualification equivalent to the prescribed qualification, the rule/ authority (with number and date) under which it is so treated must be furnished with the application form.
- II. There will be Document Verification and Interview by the Selection Committee based upon which candidates will be selected. At the time of document verification, physical presence of the candidate is mandatory and no authorization will be entertained.

N.B: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/ her application shall be rejected and disciplinary/ legal action as deemed proper will be initiated against him/her.

7. Selection of Candidates:

- a) The application of candidates which will be received within prescribed date and time will be scrutinized by the committee and eligible candidate will be called (through E-mail) for Walk-in-Interview before the Selection Committee of the SLNMCH, Koraput in a scheduled date and time.
- b) In case of multiple candidatures for a single Super Special Speciality posts, the selection will be made on the basis of merit and experience.

- c) Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:
- HSC/ Matriculation-20% of total percentage of marks secured.
 - Intermediate Science-20% of total percentage of marks secured.
 - MBBS examination-20% of total percentage of marks secured.
 - MD/MS examination- 20% of total percentage of marks secured.
 - DM/ MCh examination- 20% of total percentage of marks secured.
- d) In case of tie, it will be resolved as follows:
- i. The candidate securing more mark in MBBS shall be placed in higher rank.
 - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- e) **Weightage for experience:** 5 marks per year of experience as super specialist.
- f) **Weightage for research publications:** 5 marks per publication; (publication as per norm of NMC shall be considered).
- g) In case, the candidate engaged to a post, fails to report before the authority , the next candidate in the panel may be given a chance or any other steps to be taken will be decided by the Selection Committee.

NB: Any other related information/ changes if required shall be notified in the website of SLNMCH, Koraput i.e. <https://slnmch.nic.in/>. All communication shall be made through the Official mail id of the institute.

8. Other Terms and Conditions:

- i. The number of visits (weekly, monthly or bimonthly) by the super-specialist doctors will be decided basing upon the clinical load.
- ii. The expenditure towards hiring of such doctors will be borne from DMF or CSR fund at the disposal of District Administration.
- iii. The consulting room for the doctor will be provided by the authority of SLNMCH, Koraput.
