ADVERTISEMENT FOR FILLING UP OF POST OF JUNIOR RESIDENT ON CONTRACTUAL BASIS IN SLNMCH, KORAPUT

Eligible candidates are invited for <u>Walk-in-Interview</u> for selection of the posts of <u>Junior Resident</u> in SLNMCH, Koraput on <u>contractual</u> basis. The applicant must have acquired the required qualification for the post applied for, on or before the date of counselling. The engagement shall be purely temporary for a period of one year which may be extended on year-to-year basis for a maximum period of 3 years subject to requirement and satisfactory performance. The posts are non-practicing. The direct candidate will be paid consolidated amount as notified by Govt. from time to time. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable. Eligibility of application will be guided as per the provisions mentioned here under:

1. Available vacancy : JR-22

(The above vacancy is strictly provisional. It may change on the date of walk-in-interview as per requirement)

2. Age : Must be less than 70 years

3. Schedule of Walk-in-Interview: Date of Interview: 14.05.2025

Reporting Time : 10:30 am to 12:30 am

Venue : LT-3, SLNMCH, Koraput

4. Eligibility and Qualification for Junior Residents

- I. Qualification for Junior Residents:
- a) A candidate must possess a MBBS degree (for Medical stream) or equivalent degree recognized by MCI/NMC/as the case may be.
- b) The candidate must have completed the compulsory one-year rotating internship
- c) The above qualifications must have been obtained on or before the date of counselling/walk-in-interview.
- II. Other Eligibility Conditions for Junior Residents:
- a) The candidate must be a citizen of India.
- b) The candidates must have registered their Medical Qualification at Central/ State Medical Council. (Permanent Registration)
- c) Candidates having post-graduation in any discipline or are continuing or have completed three years tenure as Senior Resident/ Tutor/ Junior Resident in any MCI/ NMC permitted/ approved/ recognized institute are not eligible to apply.
- d) Candidate who are serving under OMHS cadre on regular basis are not eligible to apply.

5. Procedure of Application:

- a) Interest candidates shall fill up the Google form as a pre-registration process to participate in the walk-in-interview latest till 5 PM of 13.05.2025.
- b) The Candidate shall download the Application Form annexed in this Advertisement (Page 4 & 5) and come for the interview with duly filled in Application form and all requisite Original documents and self attested photocopies of required documents.
- c) They have to come with a demand draft of <u>Rs. 500/-</u> in favour of "SLNMCH RECRUITMENT" Account No.43231659018 payable at State Bank of India, SLN Medical College Branch, Koraput (IFSC Code-SBIN0064554) towards application fees. The application fee is not refundable at any circumstances.
- d) At the time of documents verification, physical presence of the candidate is mandatory and no authorization will be entertained. The candidates who fail to produce the original document during walk-in-interview will be rejected. No undertaking towards production of any such original document at a later date shall be entertained.
- e) After successful verification of the documents, a Provisional Merit list shall be prepared and notified in the website of SLNMCH i.e. <u>www.slnmch.nic.in</u>.
- f) The grievances if any will be allowed to be put forth to the official mailslnmchkptrecruitment@gmail.com.
- g) The grievances if any will be examined and a final merit list will be notified in the website. The final list will remain valid for a period of one year or till subsequent advertisement whichever is earlier.
- h) The appointment/ engagement order shall be uploaded in the website of SLNMCH, Koraput.
- Engagement will be on the basis of merit. The Direct candidate must report before the authority within 7 days of issue of appointment order.
- j) In case the candidate appointed, fails to join in time, then the next candidate in the panel for the subject may be given a chance.

N.B: In case any candidate is found to have provided a false information or certificate etc. or is found to have withheld or concealed any information, his/ her application shall be rejected and disciplinary/ legal action as deemed proper will be initiated against him/her.

6. Selection Process:

- a) Selection will be strictly on the basis of merit list prepared on basis of career marks. Weightage for different examinations shall be as under:
 - HSC/ Matriculation-20% of total percentage of marks secured.
 - Intermediate Science-20% of total percentage of marks secured.
 - MBBS/ M.Sc examination-60% of total percentage of marks secured.
- b) One mark will be deducted from the total Career mark for each extra attempt taken to pass the examination.
- c) In case of Foreign Medical Graduates (FMG) the marks secured in the subject as per the NMC/ MCI conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such a marksheet, their marks will be taken as 50%.
- d) In case of tie, it will be resolved as follows:
 - The candidate securing more mark in MBBS/M.Sc shall be placed in higher rank.
 - ii. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
- e) The selection committee at their discretion may short list the merit list to reasonable number as per the available vacancy.

f) Any clarification/corrigendum/ addendum if required shall be notified by the chairman/convenor in the website of SLNMCH, Koraput i.e. <u>www.slnmch.nic.in</u>. All communication shall be made through the website of SLNMCH, Koraput (No Postal/ Personal Communication will be made).

- k) Certificate of Medical Registration from OCMR (Both up to date UG & PG). Those who are registered in other state councils must submit NOC from the concerned council and proof of online application to OCMR.
- Valid Photo ID issued by the Govt. authorities i.e Passport/ PAN Card/ Voter ID card/ Aadhar Card
